ECOLOGICAL STANDARDS

Goal: improve or sustain ecosystem and species health

Stewardship

- Voluntary Conservation
 - We strive to practice precautionary fishing to minimize bycatch, waste and habitat impacts.
- Improving Best Industry Practices
 - We share ideas and information in an effort to improve fisheries resources and marine habitat health as well as the quality of the catch.
- Promoting Diversified Fisheries
 - We commit to being ever-observant of both opportunities and challenges that may surface as a result of changing ecological and economic conditions. Syncing fishing efforts with seasonal changes in fisheries promotes resilience of the food web and fishing communities.

Participate in Fisheries Research

- Innovation and Core Capacity to Experiment
 - We want to "'fish smarter, not harder" and experiment with gear and hull design.
- Collaborative Research to Inform Stock Assessments
 - We work with marine researchers and share our own observations made about the health of fish stocks.
- Reduce Carbon Footprint
 - We are investigating and plan to implement —where possible —innovative gear designs in an effort to conserve fuel and save money.

Policy Engagement

- Participation in Fisheries Management
 - ➤ We share ecological knowledge about fisheries resource observations made while monitoring harvest and are engaged with resource managers at local, regional and federal levels.
- Advocate for Ecosystem-based Management
 - We pay attention to the health of the whole marine ecosystem, not just individual species we catch.
- Compliance with Fisheries Regulations
 - We work within the rules and regulations of the local, regional and federal management systems, as well as those of the Coast Guard.

Fishing for Future Generations

- Access to Fisheries/Fishing Rights
 - We take steps to establish and facilitate fair and balanced transfers of fishing access rights that benefit community based fishermen.

 - We are committed to fostering professionalism of our crewmembers, and we share our knowledge and boat skills gained from our time on the water.

 - We are working to ensure that people who live in ports where seafood is landed can purchase and eat the local catch.

 - We strive to be the best information sources about local seafood because we care about the fish and our future.

 - We look to work first with other local business for services and goods.

 - We are individual owner/operators, and each CFN member group determines the best organizational structure to support our fleet.
- Equitable Governance
 - We advocate for rules that protect and promote long-term community well-being, and for a stronger voice in fisheries governance.

 - We take pride in our work and seek to build respect for commercial fishing and related jobs in our communities.

Resilient Fishing Businesses

- Refine Business Operations
 - We work to improve the "bottom line" of businesses by developing business plans, managing accounts in responsible manner, keeping books in order, ensuring tax compliance, and reporting on a regular basis.
- Business Stability
 - We strive to stabilize the other aspects of our fisheries through participation in fisheries management processes, and by giving attention to the local, state and federal laws that impact our businesses.

- Maintain or Grow the Number of Shore-side Jobs
 - ➤ We take actions to maintain or restore our working waterfronts to vibrant hubs that contribute to the local economy on and off the docks.

- Traceability of the Catch
 - We are working to implement accurate, cost effective, and easy to use traceability tools which ensure truth and transparency in seafood sourcing.
